### SUMMARY

Responsible for cleaning and resetting tables, monitoring tables for customer needs and duties requested by supervisory personnel, in a efficient courteous manner displaying a high standard of customer services.

### ESSENTIAL DUTIES AND RESPONSIBILITIES

- Shall finish cleaning tables when guests are through.
- Will assist servers with pre-bussing of tables when customers are seated.
- Shall assist with beverage service as needed.
- Shall reset all tables according to the policy for a particular meal.
- Shall remove all soiled dishes, glasses, and flatware to the dish room.
- Shall stock and/or replenish stock of all food and supply items as well as dishes, glasses, flatware, jellies, butter, etc.
- Shall police floor areas to restock salad, salad dressings, etc.
- Shall set up and take down banquet room set-ups.
- Shall clean booths, glass, vacuum, (includes mopping).
- Shall clean and reset banquet rooms as needed.
- Shall perform other duties as needed.

### QUALIFICATION REQUIREMENTS

To perform this job successfully, an individual must be able to perform each essential duty satisfactorily. The requirements listed below are representative of the knowledge, skill, and/or ability required. Shall be at least 18 years old or older. Must be able to work unusual hours, days, nights, weekends and holidays. Must be able to withstand a background check. Preference given to qualified Menominee or other Native American applicants.
