SUMMARY

This position is responsible for the overall support and maintenance of the Network Infrastructure and Users access within the organization.

ESSENTIAL DUTIES AND RESPONSIBILITIES

Shall be the primary person responsible for the support, administration and maintenance of the, Microsoft, Linux, IBM and HP servers/networks within the organization.

Shall be responsible for the daily maintenance and support of HP Servers, 3Par SAN, VMware and Cisco Networking environment.

Shall be responsible for design and testing of all network protocols implemented on the public and private computer networks.

Shall be responsible for developing and maintaining documentation related to the structure of the MCR data and computer networks.

Shall hold primary responsibility for ensuring Data backups for all systems are done and shall share system backup duties with other IT staff members.

Shall perform monthly tests of the backup systems and to ensure data and backup procedure integrity.

Shall ensure all patches, updates and upgrades are installed on all network servers and clients on a regular basis.

Shall assist in installation of new network equipment or cabling.

Shall share in On Call duties with other department staff members one week per month

Shall provide Level II desktop support as required by technicians during normal business hours as well as after hours

Shall maintain and extend as necessary the Active Directory structure to ensure efficient use of resources

Shall serve as network security administrator and ensure compliance with MIGC as well as MCR policy, procedure and best practices

Shall perform routine assessments of network infrastructure and make recommendations on upgrades and new technology

Shall assist director in implementing and enforcing computer network policies and procedures

EDUCATION and/or EXPERIENCE

Candidate shall have demonstrated a good work record in previous positions. Must possess a minimum of Associates Degree (Bachelor's Degree Strongly Preferred) in a computer related discipline and a minimum of two years experience in a Microsoft Network environment. Microsoft certification a plus but not necessary.

The candidate must have extensive knowledge of Microsoft servers and networks and a strong background in Cisco networking. Any Cisco certifications are strongly preferred. A thorough knowledge of TCP/IP networks infrastructure and networking components. A good working knowledge of PC troubleshooting and deployment with at least two years experience working in a Network environment. Thorough knowledge of Microsoft Active Directory required. The ideal candidate must be detail oriented and possess good organizational skills. Must be at least twenty-one (21) years of age and able to withstand a thorough background check as required by all gaming employees. Must not have been convicted of a felony. Must not have been convicted of shoplifting or stealing within the past five (5) years. Must be able to be approved for and maintain a valid gaming license. Preference given to qualified Menominee or other Native American Applicants. Must have a vehicle and valid driver's license.

SPECIAL QUALIFICATIONS

Applicants will be given a short written test to qualify for an interview. A score of 70% or better is required to be granted an interview for this position.

LANGUAGE SKILLS

Ability to read, analyze, and interpret simple documents, such as safety rules and regulations, technical procedure manuals, instructions, and basic correspondence, reports and memos. Ability to respond to common inquiries or complaints from system users. Ability to effectively present information in one-on-one and small group situations.

REASONING ABILITY

Ability to apply commonsense understanding to carry out instructions furnished in written, oral or diagram form. Ability to deal with problems involving several concrete variables in standardized situations.
