SUMMARY

Responsible for greeting guests in a courteous, friendly manner, and promoting specific Gift Shop items, thereby ensuring that consistent revenue is generated in the Gift Shop.

ESSENTIAL DUTIES AND RESPONSIBILITIES

- Welcome guests to the Gift Shop in a friendly, courteous manner, working to achieve a maximum level of guest service and satisfaction
- Perform all functions of the cash register, including acceptance of payment for retail sales; in the form of cash, credit card, checks or purchase orders.
- Becomes familiar with all Gift Shop items and inventory, and provides assistance and information to guests.
- Responsible for closing out till at shift end and with security escort take all contents to vault where it will be counted.
- Responsible for all shortages. All shortages will be cashier's responsibility to re-pay.
- Responsible for adhering to our WE CARD PROGRAM, (NO SALES OF TOBACCO TO GUESTS UNDER AGE OF 18.)
- Responsible for stocking, cleaning, dusting, folding clothing, facing shelves daily, and rotating cigarettes when restocking to prevent dry products.
- Maintains a neat, clean work area.
- Ensures proper inventory control, by maintaining accurate records of merchandise sold and stock on hand.
- Responsible for performing monthly inventory count.
- Maintains a working knowledge of facilities and special and upcoming events on property, in order to advise guests of same, whenever possible.
- Communicates important, relevant information to following shift.
- Assists the Gift Shop Manager and Supervisor in creating and setting up displays of merchandise.
- Facilitates the flow of information, by attending regularly scheduled departmental meetings.
- Inspects merchandise, to ensure it is correctly priced and displayed.
- Responsible for maintaining a consistent, regular attendance record.

QUALIFICATION REQUIREMENTS

To perform this job successfully, an individual must be able to perform each essential duty satisfactorily. The requirements listed below are representative of the knowledge, skill, and/or ability required. Must be Twenty-one (21) years of age or older to apply. Must be able to work weekends and unusual hours. Must have previously worked with computers and be able to explain such work. CRIMINAL BACKGROUND MINIMUM REQUIREMENTS

No person shall be eligible for employment at Menominee Casino Resort/Thunderbird complex if they have been convicted, or have a pending unresolved charge of:

- Any crime which would require compliance with the reporting requirements for sex offenders pursuant to Menominee or Wisconsin law; or
- A felony conviction of any kind in the immediately preceding two years
- A crime of any kind related to gambling in the immediately preceding two years
- A crime of any kind related to theft, fraud, or misrepresentation in the immediately preceding two years;
- A crime of any kind related to a crime of violence, or involving domestic violence, or a drug offense involving sale of drugs, or possession with intent to sell drugs during the immediately preceding two years.

LANGUAGE SKILLS
