
Every Menominee knows about the disastrous effects which termination has had. We, here in the aftermath, are trying to reconstruct a new society that will make the Menominee Indian Wribe into an independent and sovereign nation. It is now within our power to become united in an effort that will make the Menominee Reservation the residence of a unique, prosperous, and self-sufficient social structure. It is now the time for every Menominee to become responsible for his fellow Menominee by keeping his eyes and ears open to information which will illuminate the problems we are about to encounter. If we are silent, uninformed and uninvolved, then we will be easy prey to the stronger forces in society which seek power and domination.

At this crucial time in our history, it is within our power to be the masters of our own destiny. We now have the opportunity to become a strong, intelligent, and independent group of people -- a sovereign nation. But we must know what restoration means so that we know what to do, what to vote for, who to stand behind. We must understand the process of restoration before we can become intelligent in ironing out the problems that go along with it. We must stop and listen to what others have to say or we will be faced with the problem of lack of communication.

Everyone has a general idea of what restoration is all about, but let me trysto briefly summarise it for you. Restoration is the result of an act which (1) repeals the Act terminating federal supervision over the property and members of the Menominee Indian Tribe of Wisconsin, (2) renews our status as a federally recognized tribe, and (3) restores federal services to the community such as health care, jobs, and financial aid. The goal of the Menominee Restoration Committee is to accomplish these objectives: A Enrollment, B. Drawing up a constitution and By-laws. C. Contracting for services.

Because we are once a ain a federal recognized write, our land will be Tax exempt. That will mean M.E.I. saves \$450,000 each year from would-be property tax money and \$440,000 on income taxes. As a result of the proposed transfer plan (PTP) which transfers our land and assets into Federal trust. This plan doesnot in any way mean that the government takes control of our assets but rather that the U.S. government becomes, in a sense our bonker.

To become involved in these affairs, you as a Menominee Indian must attend meetings. This Newsletter contains the information you will need to keep up with such current happenings.

WOLF RIVER COUNCIL ON ALCOHOLISM September, 1974 Narrative Report

A training conference was held at Winnebago Institute on September 27, 28 and 29. Alcohol Drug Coordinators representing many Wisconsin counties and 51.42 boards were in attendance as well as counselors, social workers, correctional workers and others in the field.

The conference was sponsored by Winnebago Mental Health Institute, Bureau of Alcoholism and other Drug Abuse, Wisconsin Association on Alcoholism and Other Drug Abuse, Counselors Alliance on Alcoholism and Other Related Problems. The conference was entitled "One Big Happy Family?" The agenda included good basic counseling sessions, experiential exercises and one long session broken into three groups of "psychodrama". The last item of the agenda on Friday was a panel "Chapter 198 Sixty Days Later."

W.H. Fredenberg of W.R.C.A. appeared on the panel along with Bob Nelson of Milwaukee and Dennis Bobo of Madison.

Defores Tomow the new alcoholism counselor of W.R.C.A. and Tillie Oshkeshequoam alcoholism counselor W.R.C.A. attended and participated in the conference.

A staff meeting was held with the * volunteer counselors and with Leonard Oshkeshequoam, Employee Counselor MEI, on Monday evening September 30th. A system of coordination of counseling and follow up was developed. Also the policy of utilizing local community resources ie. counselors AA, and Dr. Rhinardy to the fullest extent, was emphasized. Client assignments were made and copies given to the counselors and Leonard. Any changes will be shared by informing each other, to insure that the most benefit results from the efforts of the counselors.

The 51-42 Board included funding for W.R.C.A. in it's 1975 budget. W.R.C.A. is also submitting an application for a continuation of the Hughs Formula Grant, this is due to some uncertainty on the amount of funding available for the 51-42 Board.

MENTAL AND DEVELOPMENTAL HEALTH PROGRAM

Menominae County's 51.42 Board, and arm of the county board responsible for services to residents with disabilities in mental health, mental retardation, alcoholism and other drug abuse, has just recently opened a health care center. Prior to September 1, services in all disabilities have been minimal, and, while the state mandates its operation by law, has had only volunteer staff.

Board members are; Mr. Harper Fredenberg, who has also volunteered as coordinator for Alcoholism and other drug abuse services, Mr. Robert Johnson, chairman, Mr. Fred Miller, Mrs. Lorene Pocan, Mr. Al Frechette, Dr. Michael Reinardy, Mrs. Ellen Swedberg, Mr. Robert Wheelock and Ms. Ruth Waukau.

Volunteering as acting program director, Ms. Ruth Waukau and Mr Fredenberg, thru two federal grants, enabled Menominee County to expand the services in alcoholism & other drug abuse. In a contract with Wolf River Council the 51.42 hoard has hired two counselors to provide community education, consultation and counseling. They are Tillie Oshkeshequoam and Ms. Leslie Waukau. The Wolf River Council has hired Mrs. Defores Tomow to take over Mrs. Oshkeshequoam duties.

The Health Care Center, just opened this week of October 1, 1974 will provide counseling services to children, adolescents and their families. In addition education and consultation will be available to all residents, agencies, and schools. Backup services of a psychiatrist and ps, chologist will be available in the community. This entire program is made available through a contract with the Marathon County Health Care Center. At present the staff includes Ms. Kuth Waukau, social work supervisor, Mrs. Ruth Daniels, a registered nurse and Mrs. Josie Tourtillott, secretary. Ms. Waukau continues as acting director for all operations of the 51.42 Board. Another position remains open for a mental health aide.

M.E.I. PROPOSED TRADFER PLAN by Al Fowler

By this time most Monominees should be aware of and have knowledge of the Proposed Transfer Plan. MEL Voting Trust and the Board of Directors are to submit this plan to congress with in one year from the enactment of the Monominee R. toration Act which was December 22, 19/3.

MEI has already held many informational meeting in which the Menominees were afforded the opportunity to give suggestions and ask questions to insure their input.

The Native American Rights Fund of Boulder, Colorado, is in the process of drafting the final updated version incorporating the suggestions of the BIA and the Tribe.

Also every effort has been made to insure that the language in the Trust Agreement gives the Menominee maximum self-determination. It will also limit and specify the role of the Secretary of the Interior in our affairs.

This plan is one of the most important phases of the Restoration process because it will give the land and assets of the Menominee corporation its tax exempt status.

After the plan is carried out it will increase MEI's liklihood of paying dividends to the tribal members because it will releive MEI of the heavy tax burden. MEI has never been able to pay dividends to its shareholders.

This plan will also increase the participation of tribal members in corporate affairs because the Voting Trust will be dissolved.

At the beginning of the Termination era in 1961 all enrolled Menominees received a \$3,000 income bond payable in the year 2000. After this plan is carric through your income bond will have a greater chance of reaching it mature face value. With the heavy tax liability on MEI assets the bonds and their annual interest payment placed a severe financial burden on the corporation.

With the transfer of our assets into trust, we will have added protection from



COMMUNITY SCHOOL MAKES COME-BACK The Menominee Community School at the Keshena Visitor's Destination center is back into the swing of things after a week delay. The delay resulted from problems which involved funding and personel.

The school director, Nick, Wodger; and the chairman of the NCUC, Ande Lenay were pressured to resign from the MCEC. Carol Dodge has also resigned because she moved to Denver Colorado. This leaves the Menominee County Education Committee open to nominations for three vacant seats. After election of three members to the seven member committee, the committee will then elect a chairman. This election will be held on October 17th at 7.30 p.m. Alex Askenette is now the acting chairman of the MCEC; Al Pyatskowit is the school director; and Tom Davis is the assistant director.

Thru efforts by the Restoration Committee and the MCEC, the school has secured \$30,000 of funds from the BIA, and \$78,000 of funds from the Wisconsin Deptof public instruction. This budget is sufficient to pay for expenses for the school thruout the entire year.

The Community School has a potential for 65 high school students and now has 45 enrolled.

There are also many projects which the school sponsors. Among these are: The University Without Walls (involving 45 adults); the Community Counseling Certification Program; the Teacher Training Project (15 Menominee college students); the Indian Teachers for Indian Children Project; the Title IVB Project (counseling & tutoring); The Wisconsin Native American Teacher Corps Project; and the Planning and Research Project which is designed to ascertain how feasable a community school is for the Menominee Reservation.
