SCOPE OF WORK:

The Dry Kiln Operator is responsible for the efficient operation and maintenance of the dry kilns and the effective drying methods for drying different species of wood in accordance with industry standards.

ESSENTIAL DUTIES AND RESPONSIBILITIES:

Must have the knowledge, skills, and ability to perform the following:

- 1. Establishing and implementing drying schedules for each specie going through the drying process to maximize value uptime capacity and efficiency.
- 2. Review and analyze current kiln drying processes and develop a documented procedure.
- 3. Implement a moisture testing procedure.
- 4. Safe operation and maintenance of high and low pressure of steam controls and equipment including actuators, fans, valves, gauges, etc.
- 5. Basic computer skills to set up, modify, and monitor drying schedules for various species and thickness of lumber.
- 6. Preparing drying activities report weekly for sales and production meeting.
- 7. Assist with the loading and unloading of lumber charges.
- 8. Evaluate pre-drying processes (stickering, staging, loading, etc.) and recommend process changes.
- 9. Tag and monitor all sticker stock lumber designated for kilns.
- 10. Be on call during nights, weekends, and holidays and work flexible hours to meet production deadlines.
- 11. Maintain a clean and safe work area.
- 12. Work independently, efficiently, with minimal supervision.
- 13. Perform other duties as assigned by supervisor.

WORKING CONDITIONS:

Works in extreme hot, cold, noisy, dusty work environment. Must be able to lift up to 75 lbs. Must wear all appropriate safety apparel and equipment and comply with all safety policies and practices of MTE.
