### **SUMMARY**

Responsible for accurately recording audits daily totals in a timely manner, thereby ensuring smooth and efficient operations in the Revenue Audit.

#### ESSENTIAL DUTIES AND RESPONSIBILITIES

- Responsible for daily revenue audit for Casino vault transactions.
- Enters daily information into Revenue Audit Report forms; runs back-up reports.
- Prepares backup documentation for journal entries.
- Evaluates various situations, with respect to Revenue Audits, and determines how best to handle them.
- Ensures that a maximum level of company-wide service and satisfaction, in the area of Revenue Auditing, is achieved and maintained.
- May attend regularly scheduled departmental meetings, at direction of supervisor, to facilitate the flow of information throughout the property and point out areas of concern.
- Held accountable for the accuracy and thoroughness of departmental records and reports.
- Responsible for maintaining a consistent, regular attendance record.
- Any other duties as assigned by supervisor.
